**Position Summary**: The PreOp/PACU RN is responsible for coordinating and managing patient care for surgical patients throughout the preoperative and postoperative phases. They will administer diligent care to surgical patients via assessment, monitoring, and intervention including care for the post-operative patients recovering from anesthesia (general, regional, and local). They will provide support, education, direct care to patients, and act as a liaison between the surgical team and the patient families/support systems. Using comprehensive, multidisciplinary approach to patient care, the PreOp/PACU nurse works closely with the entire surgical team. The PreOp/PACU registered nurse may serve as a: (1) Preoperative Nurse, (2) Post-Anesthesia Care Unit Nurse, (3) Conscious Sedation RN, (4) Pre-Admission Testing or (PAT) Nurse.

### Standard Job Requirements: At all times, employee shall satisfy the following requirements:

- 1. Adhere to and support PSMC's Code of Conduct and WISER values.

- 10. Maintain strict confidentiality of all patient matters and recognize situations where confidentiality should be maintained even if not legally required.
- 11. Respect the importance of compliance and quality programs and support the same.
- 12. Possess computer knowledge/skills and the ability to learn and adapt to new programs and software.
- 13. Participate in employee training, Disaster Preparedness and emergency events.
- 14. Perform other job duties, as assigned by a supervisor.

# Essential Duties, Functions and Responsibilities: At all times, employee shall be able to perform the following essential functions of the job, with or without an accommodation, as set forth below.

- 1. PreOp/PACU Nurse works within the surgery department and will be available to assist the RN Circulator in the OR if situation warrants, ensuring a safe environment for optimal surgical outcome and acts as a patient advocate throughout the perioperative continuum of care.
- 2. PreOp/PACU RN's wear hospital laundered scrubs.
- 3. Must possess the skills required to perform hemodynamic monitoring, pain management (i.e. PCA, epidural), cardiac monitoring, vascular access device management and airway management.
- 4. Interpret information accurately from various noninvasive and invasive monitors.
- 5. Conducts individualized age-appropriate patient assessments and plan of care, prioritizing the data collection based on the patient's immediate condition or needs according to PSMC procedures or protocols.
- 6. Assesses patients prior to surgery and post-operatively following PSMC policies/procedures adhering to standards of care (i.e. ASPAN-American Society of Paranesthesia Nurses and AORN-Association of perioperative Room Nurses).
- 7. Assists in patient positioning for anesthesia regional blocks to ensure the patient remains free of injury.
- 8. Knowledge of use, maintenance, and troubleshooting of equipment, instruments, and supplies.

- 9. Performs appropriate treatments (i.e. initiates IV, places appropriate VTE prevention hose/wraps, etc.) as ordered by physician in an accurate and timely manner.
- 10. Ensures accurate completion of the PreOp Checklist and gives face to face handoff to the OR Circulator or PreOp/PACU RN at transfer of care or for relief report.
- 11. Provides individualized patient/family education and discharge planning customized to the surgical patient and his/her family. Ensures that the patient/family's questions are answered and that the patient/caregiver understands instructions.
- 12. Documents patient assessment findings, physical/psychosocial responses to nursing interventions and progress towards problem resolution in the EMR.
- 13. Assess patient's postoperative status at intervals according to facility or health care organization policies and procedures to include the patient's
  - a. cardiovascular system,
  - b. respiratory system and airway management needs,
  - c. neurological system,
  - d. hemodynamic stability,
  - e. pain and comfort needs, and
  - f. mental status.
- 14. Describes the underlying pathophysiology of commonly encountered disease processes.
- 15. Describes the physiology associated with various anesthesia techniques and surgical or procedural interventions.
- 16. Monitors patients for changes in condition and reports any abnormal findings to the anesthesia provider and/or surgeon.
- 17. Appliesy the Aldrete scoring/discharge criteria for patient transfer/discharge score accurately as defined by PSMC policy and procedures.
- 18. Initiates appropriate nursing interventions in the care of the patient including but not limited to:
  - a. managing patient recovery from anesthesia general,MAC (monitored anesthesia care), Regional and Local
  - b. protecting patient from injury caused by positioning, thermal sources, and extraneous objects;
  - c. communicating the patient's current status throughout the perianesthesia continuum of care;
  - d. providing acute pain and comfort management as needed;
  - e. administering medications correctly by implementing the 7-rights of safe medication practices (i.e., right patient, right medication, right dose, right time, right route, right indication, right documentation);
  - f. performing interventions to maintain the integrity of the patient's wound and tissue perfusion at or above baseline levels;
  - g. performing interventions to maintain the status of the patient's genitourinary, gastrointestinal, musculoskeletal, endocrine, respiratory, cardiovascular, and neurological systems, and fluid, electrolyte, and acid-base balances at or above baseline levels;
  - h. performing interventions to ensure the patient is at or returned to normothermia at the conclusion of the immediate postoperative period;
  - i. performing interventions to protect patient from infection;
  - j. managing patient's other co-morbid conditions as applicable;
  - <u>k.</u> managing patient's fluid as prescribed;
  - I. assessing knowledge level of the patient and/or designated support person and providing education regarding expected psychosocial response, nutritional management, medication management, pain and comfort management, wound management, and expected responses to the operative or invasive procedure;
  - m. involving patient and/or designated support person actively in decisions affecting his or her perioperative plan of care and the rehabilitation process;
  - n. protecting the patient's rights, dignity and privacy;
  - o. providing age-specific, culturally competent, ethical care within legal standards of practice;
  - p. providing consistent and comparable care regardless of the setting and;

k.q. evaluation of the patient's progress towards outcomes.

- I. assessing knowledge level of patient or designated support person and providing education regarding the expected psychosocial response, nutritional management, medication management, pain and comfort management, wound management, and expected responses to the operative or invasive procedure;
- m. involving patient or designated support person actively in decisions affecting his or her perioperative plan of care and the rehabilitation process;

- 23. Initiates and/or assists in emergency resuscitative measures according to adult & pediatric resuscitation and advanced life support protocols.
- 24. Attends department and medical staff meetings, trainings, and task forces, as appropriate.
- 25. Assists in inventory/supply management and reviews daily charges for procedures performed.
- 26. Participates in department ongoing quality improvement activities such as chart review and policy review.
- 27. Pursue professional growth and maintains specialized knowledge and skills in perioperative nursing practice by participating in professional organizations and on-going continuing education/in-service training with emphasis in perioperative practice.
- 28. Performs function of the PAT RN role commiserate with experience and as assigned.
